Quartermaster Automatic Knife Compliance Form

PLEASE READ CAREFULLY. THIS FORM MUST BE COMPLETED BEFORE QUARtermaster CAN SHIP ANY AUTOMATIC KNIFE

Please read and complete this page and return with a copy of your government, state or local law enforcement, military, EMT, Fire or rescue personnel identification. Fax to Quartermaster at 866.290.3389 or email to id@QMuniforms.com.

Until both this completed form and appropriate identification are received by Quartermaster, your order cannot be processed. Quartermaster will sell automatic knives only in accordance with federal law (18 U.S.C Section 1716(g)) which prohibits the mailing of automatic knives with the following exceptions:

1. to civilian or Armed Forces supply or procurement officers and employees of the Federal Government ordering, procuring or purchasing such knives in connection with the activities of the Federal Government.
2. to supply of procurement officers of the National Guard, the Air National Guard or militia of a state, territory or the District of Columbia ordering, procuring or purchasing such knives in the connection with the activities of such organizations.
3. to supply to procurement officers or employees of any State or any political subdivision of a State or Territory ordering, procuring or purchasing such knives in connection with the activities of such government and;
4. to manufacturers of such knives or bona fide dealers therein in connection with any shipment made pursuant of an order from any person designated in paragraphs (1), (2) and (3). The Postal Service may require as a condition of conveying any such knife in the mail that any person proposing to mail such knife explain in writing to the satisfaction of the Postal Service that the mailing of such knife will not be in violation of this section

Quartermaster must have proof of your eligibility under one or more of these exceptions before we can complete your order. Please note that state and local law may impose additional purchasing restrictions and compliance with such additional restrictions is the responsibility of the purchaser. Quartermaster makes no warranty of any kind, express of implied, including but not limited to fitness for a particular purpose. No sales to minors. By placing an order the purchaser represents that the product(s) will be used in a lawful manner and that purchaser is of legal age. Quartermaster is not liable for the misuse or unlawful use of any product.
